GENERAL INFORMATION

This year the Bo'ness Hill Climb meeting comprises two one day events, one on Saturday 12 September and one on Sunday 13th September. The committee reserves the right to refuse entries for any reason.

A) ENTERING EVENTS

Entry Forms for the event should be sent to the Competition Secretary: - Alex Brown, Newbarn, Stenton, East Lothian EH42 1TB Tel: 01368-850226 (Before 21:30 Hours please) E-mail alex@bonesshillclimb.org.uk Refunds will be as specified in the ASRs should you be unable to compete at the event. Please ensure that your entry is accompanied by a cheque for the correct amount. Please also ensure that if you have to cancel an entry, you advise the Competition Secretary as soon as possible. This will give others a chance to take your place. Entries will not be acknowledged unless a written request is made and a stamped addressed envelope is supplied by the competitor and marked 'Entry Acknowledgement'.

B) SELF-STARTING

It is helpful if cars are capable of re-starting in the holding paddock. This is usually achieved by sending a spare starting battery to the holding paddock on the breakdown truck at the start of the meeting. Other equipment required (e.g. Motorised starters) may be sent at the discretion of the Clerk of the Course on the breakdown truck during the meeting. Cars without self starting need to advise the officials on the entry form to allow arrangements to be made.

C) CLASSES

Please check the number of the class you are entering in Appendix I.

D) DOUBLE ENTRIES

Please mark clearly on entry forms the principal and second competitor. The principal competitor will run in class, the second competitor will normally run in the batch preceding.

E) DOUNE HILL CLIMB

September Doune has now been moved to the 26th and 27th September 2009 and those of you who proposed doing both events may wish to consider leaving your trailer and car locally to save a drive. If you wish to do leave a trailer etc please contact Alex Brown, Vernon Williamson or Bill Drysdale.

F) Motorcycles

There are a separate set of entry forms for Motorcycles and that part of the meetings is under the regulation of the SACU.

2. **The event** is open to members of Bo'ness Hill Climb Revival Ltd, all clubs belonging to ESSAC, Midlands Automobile Club, Vintage Sports Car Club, Bentley Drivers Club, MG Car Club, Frazer Nash Club, Jaguar Drivers Club, Aston Martin Owners Club, Alvis Register, Club Lotus, Bugatti Owners Club, Westmoreland Car Club, Monklands Car Club and Lothian Car Club Membership Cards must be shown at the event. The program timetable will be published in the final instructions.

BHCR expects the long course to be used. This however, is dependent on the works to the course being completed on time. Should the long course not be available then the short course will be used.

3. Timed Runs

On both days, first timed runs will commence at a time to be announced by the Clerk of the Course.

4. **Scrutineering** at all events will be in class order according to the times specified in the final instructions. Vehicles must be ready for scrutineering at the correct time with the competitor in attendance - if not competitors may lose their practice run.

5. **Track length.** The length of the short course Bo'ness is some 370 yards. The long course is some 620 yards.

6. **Prevailing Regulations.** The car meetings will be held under the General Regulations of the Motor Sports Association (incorporating the provisions of the International Sporting Code of the F.I.A.), these Supplementary Regulations and any written instructions that the organising club may issue for the event. All competitors and vehicles must comply with MSA Technical Regulations. The motorcycle meeting will be held under the General Regulations of the Scottish Auto Cycle Union.

7. **Classes** are shown in Appendix I.

8. **Awards** and Trophies are shown in Appendix II.

Cheques in settlement of entry fees will not be accepted if dated after the closing date of the event to which they relate. Members of BHCR Ltd can deduct £5 from a single day's entry and £10 from a two day entry.

10. The maximum entry for the meeting is 120 vehicles plus 10 reserves. The minimum entry will be 50. The minimum entry for each class will be 5. Should any of the above minimum figures not be reached, the organisers have the right either to cancel the meeting or amalgamate classes as necessary. These figure maybe varied by the Clerk of Course dependant on the ratio of Cars to Motorcycles.

11. In the event of the meeting being over-subscribed, entries will be accepted at the discretion of the Committee.

13. Provisional results will be posted at the Secretary's office as soon as possible after each class or following the end of the event. Printed results will be handed out at the event or posted on the web-site during the week following the event. If you would prefer results to be posted to you please indicate on the relevant form.

14. Vehicles will start singly. The starting signal will be a GREEN LIGHT. Timing starts when the vehicle interrupts a light beam. The finish line will be indicated by chequered boards and/or banner and/or a white line. Timing struts in compliance with the MSA technical regulations are required on all cars. Motorcycles will use the front wheel.

15. Any protest must be lodged in accordance with MSA/SACU Regulations

16. Running order will be the class order, running order within the classes being stated in the Official Entry List and Final instructions.

17. For safety reasons numbers complying in all respects with the MSA or SACU Year book definition of size etc must be displayed on both sides and the front of each vehicle so that they are clearly visible from marshals' posts located on both the left, right and above the track.

18. All other General Regulations of the MSA/SACU apply as written.

19. Competitors whose practice run is interrupted by a RED FLAG will only be allowed a rerun at the discretion of the Clerk of the Course.

20. At all events, when shown a red flag, the competitor must bring the vehicle to a stop and await verbal instruction from a marshal

21. If any competitor is under the age of 18 years a parent/guardian signed consent form must accompany their entry.

22. Please note; the site is only open to competitors from mid-day on the Friday until mid-day on Monday of the weekend.

23. Double entries are acceptable if entry forms are clearly marked. First and second competitors must be nominated on the Entry Form; the first competitor will run in class, the second competitors will usually run in the class preceding. The running order for double entries will be intimated in the final instructions.

24. Refunds. A competitor notifying the Secretary in writing

i) Prior to the closing date for entries for that event, will be entitled to a refund of his entry fee.

ii) At any time after the closing date for that event, but no later than 5 days before the meeting, to a refund of their entry fee on deduction of an administration fee of £5.00 provided in all cases that all passes in respect of the event are returned to the Secretary prior to the meeting.

iii) Within 5 days of the event refunds of per capita & insurance are available on written application to the club. Any further repayment is at the discretion of the Club.

25. In the event of cancellation or postponement of the event for more than 24 hours, entry fees will be refunded less an administration fee of £5.00.

26. The use of slick tyres is prohibited in all classes. The type, size and tread of the tyre must remain the same throughout the meeting. All vehicles must run on period treaded tyres which may be road tyres or racing tyres as long as the latter have grooves in the tread pattern which must be lateral and circumferential and any 40mm diameter areas of the tyre must have grooves in at least two directions. Classes 11 and 12 can run on tyres and sizes appropriate to the vehicle and section I of the MSA yearbook. Class 13 must run on the tyres detailed in their championship rules. Classes 15 to 19 must run on SACU approved tyres

27. Appointments will be made to declare on unsatisfactory starts or starting infringements.

28. In determining the awarding of trophies, any competitor who wins a fastest time of day award (Fastest, Second or Third fastest) will be excluded from the individual class results. A competitor can only win one of the special trophies and these are in addition to the fastest time of day awards and the trophies will be awarded in order of precedence as shown in Appendix 2. The Club Chairman and Clerk of Course have final arbitration on this.

29. Scooters and similar. The use of motorised scooters or similar in the paddock is not permitted.

30. Animals. Following a recommendation from the Health & Safety Executive, please note that animals are not allowed at Bo'ness Hill Climb. Animals may be left in the camping/car park area provided they are securely housed.

31. No tyre warmers are allowed.

32. Only period aerodynamic aids are permitted.

33. Entry to the events is totally at the discretion of the BHCR committee and they are not required to give any reason for refusing an entry.

34 The Dr M R Chassels Trophy can only be won once in every five years by the same car / competitor combination. The Club Chairman and Clerk of Course have final arbitration on this.

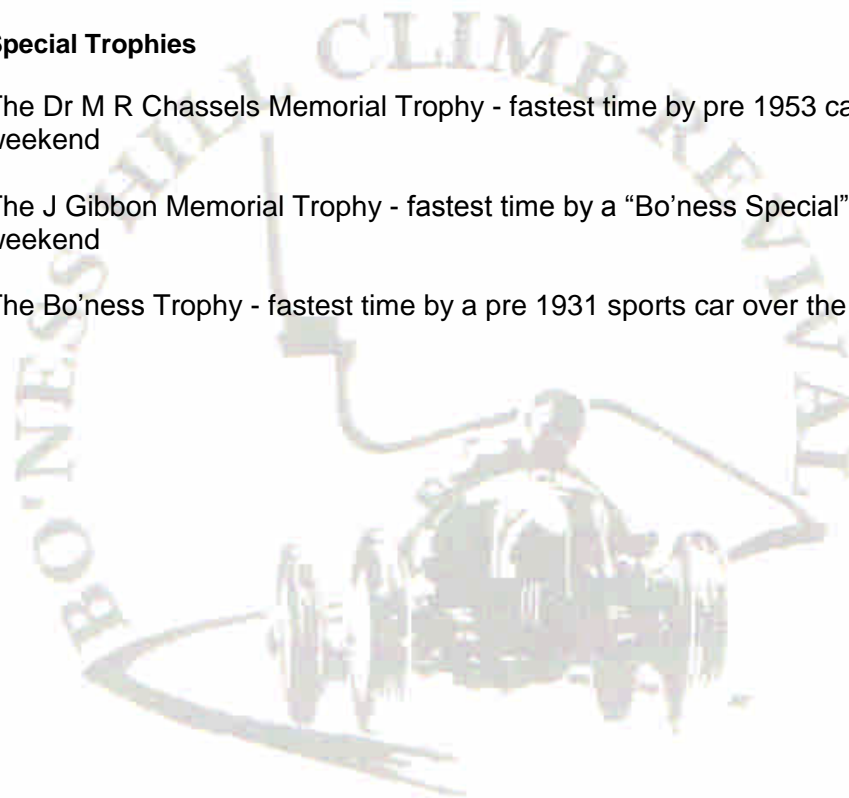
