GENERAL INFORMATION

The Bo'ness Hill Climb Revival meeting comprises of one two day event for cars and motorcycles, on Saturday 11th and Sunday 12th September 2010. There will be practice on Saturday with competitive runs on Sunday.

A) Entering Events

Entries are accepted for the event from the issue of these regulations.

Please ensure that your entry is accompanied by a cheque payable to Bo'ness Hill Climb Revival Ltd for the correct amount.

Refunds will be as specified in the Supplementary Regulations should you be unable to compete at the event.

Please also ensure that if you have to cancel an entry, you advise the Entry Secretary as soon as possible. This will give others a chance to take your place.

Entries will not be acknowledged unless a written request is made and a stamped addressed envelope is supplied by the entrant and marked 'Entry Acknowledgement'.

Please note that the timings detailed in the Supplementary Regulations, as the competitor's entry gate is part of the track.

Due to the large public attendance and the various displays it is necessary to operate to a tight time table so early arrival is essential to allow time to walk the hill and attend the competitors briefing. Please be early.

B) Self-Starting

It is helpful if vehicles are capable of re-starting in the holding paddock. This is usually achieved by sending a spare starting battery to the holding paddock at the start of the meeting. Other equipment required (e.g. motorised starters) may be sent at the discretion of the Clerk of the Course during the meeting. Vehicles without self starters need to advise the officials on the entry form to allow arrangements to be made. There is a suitable hill in the holding paddock that vehicles can use under the control of the paddock marshal for a rolling start.



C) Classes

Please check the number of the class you are entering in Appendix I.

D) Double Entries (Cars only)

Please mark clearly on entry forms the principal and second competitor. The principal competitor will run in class, the second competitor will run in the preceding batch.

E) Doune Hill Climb

September Doune is on the 18th and 19th September 2010 and those of you who propose doing both events may wish to consider leaving your trailer and car. If you wish to leave a trailer etc please contact Alex Brown, Bill Drysdale or Vernon Williamson using the details on the web site.

1. The Bo'ness Hill Climb Revival Ltd (BHCR) will promote a meeting at Bo'ness Hill Climb, Kinneil Estate Bo'ness, EH51 0PR as follows: -

2. **The event** is open to:-

Cars - Members of BHCR and any of the following invited car clubs - all clubs belonging to SACC, Midlands Automobile Club (MAC), Bentley Drivers Club (BDC), Vintage Sports Car Club (VSCC), The Formula Junior Historic Racing Association (FJHRA). Membership Cards must be shown at sign on.

Motorcycles - Riders holding a 2010 Competition licence for Road Racing or Hill Climbing issued by SACU, ACU, MCUI or a Federation whose country is a member of the European Community. Holders of licences issued by a Federation other than the SACU or ACU must have written starting permission from their FMN, valid personal accident insurance and repatriation insurance. No rider will be allowed to start without this permission or insurance. These must be produced at signing on. BHCR will not be held responsible for the repatriation of any rider. One day licences will not be valid for this event.

The programme timetable will be published in the final instructions. BHCR expects the full course to be used. Should the full course not be available then the 2009 course will be used.

3. **Prevailing Regulations.**

The car meeting will be held under the General Regulations of the Motor Sports Association (incorporating the provisions of the International Sporting Code of the F.I.A.), these Supplementary Regulations and any written instructions that the organizing club may issue for the event. All competitors and vehicles must comply with MSA Technical Regulations.

The motorcycle meeting will be held under the Standing Regulations and Sporting Code of the Scottish Auto Cycle Union and the ACU, these Supplementary Regulations and any written instructions that the organizing club may issue for the event. All competitors and vehicles must comply with SACU Technical Regulations.

5. **Classes** are shown in Appendix I

6. **Awards** and Trophies are shown in Appendix II.

7. **Trophies** In determining the awarding of trophies, any competitor who wins a fastest time of day award will be excluded from the individual class results.

8. **The Dr M R Chassels trophy** can only be won once in every 5 years by the same car or competitor. The BHCR Chairman and Clerk of Course have the final arbitration.

9. **The Jimmy Gibbon Memorial Trophy** can only be won once in every 5 years by the same car or competitor and is awarded for fastest time of the day to any vehicle competing that is listed as a Bo'ness Historic.

10. **Bo'ness Historic** all vehicles that competed at Bo'ness pre 2007 are Bo'ness Historic's and up to 1 vehicle per year nominated by the Chief Scrutineer and approved by the BHCR Chairman and the Clerk of Course as being a vehicle of special interest that *could* have competed at Bo'ness prior to 1967 will be added to the list at close of the awards ceremony. Appendix III gives the list of Bo'ness Historic vehicles.

11. **Entry Fees etc**

Cheques in settlement of entry fees will not be accepted if dated after the date of the event. Members of BHCR should deduct £5 from the entry.



12. **Double entries** are acceptable for Cars only if entry forms are clearly marked. First and second competitors must be nominated on the Entry Form; the first competitor will run in class, the second competitor will usually run in the class preceding. The running order for double entries will be confirmed in the final instructions.
13. **Age** if any competitor is under the age of 18 years a parent / guardian must sign the competitor's entry form.
14. **Maximum entry** including both cars and motorcycles for the meeting is 120 plus 10 reserves. The minimum entry will be 50. The minimum entry for each class will be 5. Should any of the minimum figures not be reached, the organisers reserve the right either to cancel the meeting or amalgamate classes as necessary.
15. **Oversubscription** of the meeting then entries will be accepted at the discretion of the Committee.
16. **Refusal of Entries** Entry to the event is totally at the discretion of the BHCR Ltd committee and it is not required to give any reason whatsoever for refusing an entry.
17. **Refunds.** A competitor notifying the Secretary in writing
 - i) Prior to the closing date for entries for the event, will be entitled to a refund of their entry fee.
 - ii) At any time after the closing date for the event, but no later than 5 days before the meeting, to a refund of their entry fee on deduction of an administration fee of £5.00 provided in all cases that all passes in respect of the event are returned to the Entry Secretary prior to the meeting.
 - iii) Within 5 days of the event refunds of per capita & insurance are available on written application to the club. Any further repayment is at the discretion of the Club.
18. **Cancellation** In the event of cancellation of the meeting, entry fees will be refunded less an administration fee of £5.00.
19. **A Valid Competition Licence** must be produced by all entrants and all competitors appropriate to the class of vehicle applicable to cars only. The relevant licence must be provided at "signing on" and before technical inspection.
20. **Scrutineer's tickets** will be provided at sign on that will be completed by a Scrutineer. The validity of the ticket will be checked prior to the competitor being allowed to the start line.
21. **Please note that the entry gate** is part of the track and will be closed at 8.45am sharp. After 8.45am you will not be able to enter the paddock till a time decided by the Clerk of Course and therefore you may forfeit your entry. Please be ready in your paddock place **no later than 8.45am.**
22. **The Competitors Briefing is compulsory.** Competitors should gather at the briefing from **9.00am onwards** and the briefing will be at approximately 9.15am on the start line. The final instructions will provide exact details. The MSA and SACU regulations state there is a penalty for not being present at the competitors briefing.



23. **Competition Numbers** Competitors will be identified by numbers which will not be supplied by the organiser.

For safety reasons car competition numbers, must comply in all respects with the MSA Year book definition of size etc and must be displayed on both sides and the front of each car so that they are clearly visible from marshals' posts located on both the left, right and above the track.

For safety reasons motorcycle and sidecar competition numbers, must comply in all respects with the SACU Year book definition of size etc and must be displayed on both sides and the front of each motorcycle or sidecar so that they are clearly visible from marshals' posts located on both the left, right and above the track.

24. **Tyres** The use of slick tyres is prohibited in all classes unless it is the control tyre for that vehicle's Formula.

Cars All cars must run on period tyres which may be road tyres or racing tyres which comply with the MSA regulations.

Motorcycles and sidecars must run on tyres which comply with the regulations of the SACU applicable to pre 1973 road racing machines.

25. **Tyre warmers** are not allowed.

26. **Aerodynamic aids** Only period devices are permitted.

27. **Scrutineering** at all events will be in class order according to the times specified in the final instructions. Vehicles must be ready for scrutineering at the correct time with the competitor in attendance - if not competitors may lose their practice run.

28. **Track length** of the Bo'ness 2008 course is some 370 yards; the 2009 course is some 579 yards and the full course some 708 yards. It is intended to use the full course for 2010. The steepest part of the track is 1 in 9; there are 7 corners and a total climb of some 120 feet.

29. **The braking area** for motorcycles is greater than 165 yards.

30. **Green Flag** will be shown during the first practice run so that the marshal posts can be identified.

31. **Red Flag** when shown a red flag the competitor must bring the vehicle to a stop and await verbal instruction from a marshal.

32. **Running order** will be specified in the final instructions with the running order within the class being numerical as stated in the Official Entry List and Final instructions.



33. **Timing** Competitors will start singly. The starting signal will be a GREEN LIGHT. Timing will be electronic and starts when the vehicle interrupts a light beam. The finish line will be indicated by chequered boards and / or banner and / or a white line. Cars must have timing struts in compliance with the MSA technical regulations. Motorcycles must start within 1 minute of the green start light.
34. **Starts** Appointments will be made to declare an unsatisfactory starts or starting infringements.
35. **Practice runs** interrupted by a RED FLAG will only be allowed a rerun at the discretion of the Clerk of the Course. There will be two practice runs per competitor at each event and competitors are permitted to walk the course **prior** to the competitors briefing.
36. **Timed Runs** first timed runs will commence at a time to be announced by the Clerk of the Course.
37. **The use of Methanol** is permitted for cars only providing the vehicle complies in all respect with the appropriate MSA regulations and any Championship regulations. Fuel for motorcycles must comply with SACU/ACU regulations.
38. **Provisional results** will be posted at the Time Keeper's office as soon as possible after each class or following the end of the event. Printed results will be handed out at the event and available on the BHCR web site during the week following the event. If you would prefer results to be posted to you please circle the appropriate answer on the entry form.
39. **Protests** must be lodged in accordance with MSA or SACU Regulations
40. **Site Hours** The site is only open to competitors from mid-day on the Friday until mid-day on Monday of the weekend during which the competition is being organised.
41. **Scooters and Similar.** The use of motorised scooters or similar in the paddock is prohibited
42. **Animals.** Animals are not allowed at the Bo'ness Hill Climb. Animals may be left in the camping / car park area provided they are securely housed and provided with adequate ventilation.
